**Re: Court-Ordered False Imprisonment**

April 3, 2007

Dear Governor Richardson,

I am writing you today in regards to a series of absolutely illegal actions taken against me by employees of the State of New Mexico.

A little background:

I am a life-long citizen and resident of New Mexico.

I am an Honorably Discharged Veteran of the US Navy (1977-1983) where I not only held a high security clearance due to my work in Weapons Systems (missiles) and various Radar Platforms, but I also volunteered for and was accepted into the Personal Reliability Program (PRP) through which I was trained for and performed Nuclear Weapons Security utilizing an array of weapons and tactics (one must be a pretty mentally stable individual to be a member of this fairly elite group).

I was married in 1988 and upon the birth of our first Child in 1991, and by mutual agreement between both Parties, I gave up my career advancement to become a full-time, stay-at-home, Father and Parent and devoted myself to that end for thirteen years until my discovery of my Spouse's infidelity in 2002. Within a year the marriage had disintegrated and she filed for Divorce (2003) presumably to be with her new-found boyfriend whom she met over the Internet.

After spending well in excess of ten thousand Dollars on supposedly top-flight lawyers who absolutely refused to take action on my behalf, I fired them and began representing myself Pro Se in November of 2003.

Needless to say, I was very naive at that point and still believed that the legal system in this State was bound by the law but what I have found out since that time tends to make me believe that (especially now with all of the other government corruption coming out) the NM Judiciary is absolutely corrupt and the laws and Constitutions are not worth the paper they're printed on. As a result I long-ago joined several Rights protection support groups especially and primarily the local Center for Family Justice. Through them I have testified in front of the NM Senate Judiciary Committee, have participated in peaceful protest marches and have appeared on their public-access television program on numerous occasions in an effort to expose the corruption that is the NM Judiciary and Bar.

Anyway, having said that, and without delving too deeply into the case, please find the enclosed flyer which I am now putting into wide circulation (including utilizing it as a tool to entice the nastiest tort attorney I can find (either within or without the State)) that is not afraid of going up against the corrupt NM system in order to sue the State back into the stone age (I have already filed a notice of intent to sue) for what they are illegally doing to me (keep in mind that the matters described within the flyer hardly scratch the surface of the illegal activities associated with the case and of the NM Judiciary in general).

So, what you are probably asking yourself now is "Why is this individual contacting me?" Well, to be honest, (and still having just a bit of my virgin naivete left within me) I thought that I would give the legislative (my districts) and executive branches of the State a crack at reigning in the out-of-control judiciary that is destroying not only parent's and children's lives but which seems to have taken it upon itself to declare the NM and US Constitutions void.

As described in the flyer, I am seeking a complete and transparent investigation of the case (as well as of the Second Judicial District Court) and I demand that the illegal and dangerous

guarding of me by Armed Government Troops be halted post-haste and those responsible held accountable under the law. You have the power to initiate such actions and I respectfully request that you do so immediately. The violation of a citizen's Rights by the government of the State of New Mexico without Due Process or Evidence can in no way be condoned or justified under the law and the oaths that its elected Officials take mandate that they take whatever action is necessary to ensure that it does not happen and to correct it if it does.


Keep in mind, this illegal guarding began in November 2005, and although they claimed that I was granted Due Process at that time, the NM Attorney General's Offices, during the referenced September 11, 2006, Hearing, not only failed to establish when that occurred (it didn't occur) but, despite the fact that there is absolutely no evidence in the Record that I said or did anything that could even remotely be considered such a grave threat to the safety and security of the Courthouse that it warranted the initiation of the extreme, provocative, and highly dangerous action of my being guarded by Armed Government Troops, also failed to establish that such a gravely threatening situation ever even occurred (it didn't occur).

The entire matter is a very dangerous and illegal sham, a harassing game being played through the outrageous abuse of power by the Second Judicial District resulting in my Rights being denied with extreme prejudice without any Evidence or Due Process and supported by the false claims of those in the NM Attorney General's Offices.

It is nothing less than False Imprisonment and must be halted *immediately* not only because of the growing liability of the State but for my own physical safety. One guard with a hangover or who is having personal problems is all that it could take for the Courthouse to have a second person killed by a guard, me. Their little game is not worth my life and it is your responsibility to ensure that [1] their little game ends immediately, [2] that those responsible for initiating and carrying out said game are immediately removed from power and prosecuted for their crimes and, [3] that appropriate safeguards are implemented so that no other citizen will ever again be illegally placed in such a position of being terrorized by the State.

I will be anticipating your prompt reply.
