I made contact with Social Worker [REDACTED]. Ron advised two days after [REDACTED] was examined at UNMH, there was evidence of light bruising on the back of [REDACTED]'s neck. [REDACTED] advised [REDACTED] brother was a witness to [REDACTED] grabbing [REDACTED] by the neck. The family is currently dealing with Court Clinic Services. [REDACTED] evaded the questions of grabbing [REDACTED] by the back of the neck. [REDACTED] was examined at UNMH, no medical attention was necessary.

On 01-24-02, Forensic Interviewer [REDACTED] interviewed nine (9) year old [REDACTED] at the Children's Safehouse. [REDACTED] disclosed his father, [REDACTED], grabbed him by the back of the neck, yelling and spitting in his face. [REDACTED] stated his father held him so tight by the back of his neck that he left marks, and he blamed it on someone else. [REDACTED] stated he and his brother were fighting over a chair when his father became angry. [REDACTED] stated he will do anything to help his mom, his mom is telling the truth and his dad is lying. [REDACTED] stated he does not want to see his father.

Contact made with [REDACTED], the mother of [REDACTED]. [REDACTED] was visibly upset, and requested criminal action against her ex-husband for child abuse. [REDACTED] stated her children are in fear of visiting their father. [REDACTED] stated she is unable to get anyone to recognize the damage [REDACTED] is doing to their children, and she does not want her children visiting with their father, due to him physically abusing them. [REDACTED] requested that I reopen a case of physical abuse to her daughter [REDACTED], at the hands of her father, [REDACTED]. I was advised by [REDACTED] attorney, [REDACTED] former attorney dismissed Child Abuse charges, in favor of Domestic Violence charges.

THE DA.

Through investigation [REDACTED] did commit SIMPLE battery upon his son, [REDACTED]. Children, Youth, and Families, did substantiate abuse against [REDACTED]. This case will be exceptionally cleared.
